Foreningen Grut-Hansen-Efterkommerne – the Family association Grut-Hansen-Efterkommerne in the following called "the association" respect your privacy and are committed to protecting it through our compliance with this website privacy policy

This Policy is based on the General Data Protection Regulation, GDPR which came into effect on the 25th May 2018 following an EU directive.

"the association" is a private non-commercial association, which use of personal data only serves the purpose of genealogy, and data will never be used in marketing nor will they be made available for commercial use unless specific permission has been given to this effect.

This Policy applies to information we collect:

- On our Website.
- In e-mail, text and other electronic messages between you and our Website.
- Through mobile and desktop applications you download from our Website, which provide dedicated non-browser-based interaction between you and our Website.
- When you sign up for any events that we host.
- When you interact with us in another way for example, contacting us with an inquiry.

Following a request to DATATILSYNET, the Danish Data Protection Agency, the Agency has sent a further description of how they interpret the situation regarding the use of personal data in connection with genealogy research:

The same general considerations, which can be seen on the Agency's information for genealogy, will be relevant after the introduction of General Data Protection Regulation, - meaning no alterations.

The expected information from the Danish Data Protection Agency is written here:

	Living persons	Deceased persons
None sensitive information	Can be published by the genealogist research, however the person in question has the right of refusal	Can be published by genealogist research
Sensitive informations	Can only be published with the explicit consent of the person in question.	Can only be published 10 years after the person in question died.

Non-sensitive information in this connection can be defined as:

- a. Birthday and birth place
- b. Date for marriage
- c. Name of spouse
- d. Closest family
- e. Other basic family information.

Following information in this connection can be defined as sensitive and will need explicit approval by the person in question before published:

- a. Photos
- b. Religious believe
- c. Adoption
- d. Sexual orientation
- e. Health
- f. Criminal record
- g. Other strictly private information

The board of the Family association Grut-Hansen-Efterkommerne, has decided to follow the above interpretation by the Danish Data Protection Agency.

The open part:

Information on the associations activities, the annual general meetings of the association, family assemblies and special issues.

Group photos from the family assemblies.

The non-public part (admission code needed)

Admission code will only be given to members of the association.

There will be websites with photos and videos from the Family assemblies

On www.gruthansen.org/genealogy, pages with the Family database pages:

The open part:

The family database contains non-sensitive information such as:

- a. Birthday and birth place
- b. Date for marriage
- c. Name of spouse
- d. Closest family
- e. Other basic family information.

Only_for Deceased persons, date and place of birth, marriage details, death etc. and notes of already known Information such as work, business life, author and expatriates in other countries.

The non-public part (admission code needed)

Admission code will only begiven to members of the association.

Information can be found concerning living persons corresponding to information for deceased mentioned under the open part.

Sensitive data for persons currently alive:

Open part - no data.

Closed part:

Information can only be provided by special permission such as:

- a. Religion
- b. Adoption

c. sexual orientation – only indirectly in connection with official social status, such as in the form of name of cohabitant or spouse of the same sex.

Usage Details, IP Addresses, Cookies and Other Technologies

As you navigate through and interact with our Website, we may automatically collect certain information about your equipment, browsing actions and patterns, including:

- Details of your visits to our Website, including traffic data, location data, logs and other communication data and the resources that you access and use on our Website.
